This agreement is approved upon signatures between the above named (referred to as the "Ghost Hunter" in this agreement) and the Collingwood Arts Center (referred to as "CAC" in this agreement), 2413 Collingwood Blvd. Toledo, Ohio 43620.

Both Parties agree to the following:

1. **PAYMENT OF FEE:** Ghost Hunter agrees to pay CAC \$35 per participant for public "Ghost Hunting the CAC" events.
2. **CONDITIONS:** As a condition of attendance, the Ghost Hunter assumes the risk of injuries to person or property arising out of his or her use of the premises and does hereby release CAC, its trustees, employees, agents, and successors from and against any claim, demand liability arising out of such injury, and will protect and indemnify CAC and those persons released with respect to any claim, demand, or liability arising out of such injury.
3. **WARRANTIES:** CAC makes no warranties with respect to the "Ghost Hunting the CAC" events. In no event will CAC be liable for direct, indirect, incidental, or consequential damages that are in any way related to the event.
4. **RULES:** Ghost Hunter agrees to abide by the following CAC rules and regulations. Any violation of a rule is grounds for removal from CAC property. Refunds will not be given.
 - Smoking is not permitted inside the building. Please use the designated smoking area in the courtyard.
 - Only small camera bags or purses are permitted. Leave any extra items in your vehicle.
 - No two-way radio communications.
 - No drugs or alcohol.
 - No outside food or drinks.
 - No Séances or Ouija Boards.
 - Removal, damage or desecration of any CAC property will result in immediate expulsion from the premises.
 - Do not open any windows in the building.
 - You may exit the building at any time. Please be advised that once you leave, you are finished for the night.
 - Be respectful of other hunters and keep noise levels to a minimum. Anyone found scaring other people on purpose will be escorted from the grounds immediately.
 - During a ghost hunt, you are free to roam any area of the CAC except those blocked off by caution tape, ropes, or locks.
5. **REFUNDS/CANCELLATIONS:** If for any reason you cannot attend the date of a "Ghost Hunting the CAC" event that you prepaid for, you may send someone else in your place as long as they are at least 18 years old. You just notify us of the change 48 hours prior to the event at info@collingwoodartscenter.org.
6. **ENTIRE AGREEMENT:** This agreement contains the entire agreement of the parties and there are no promises or written conditions in any other oral or written agreement. This agreement supersedes any other prior written or oral agreement between the parties. I hereby agree to comply with the terms and conditions of this agreement.
